FOR THE PRESIDENTIAL PRIMARY ELECTION
TO BE HELD ON
TUESDAY, FEBRUARY 28, 2012
COUNTY OF CLARE, STATE OF MICHIGAN**

TO THE QUALIFIED ELECTORS OF CLARE COUNTY, STATE OF MICHIGAN:

PLEASE TAKE NOTICE that a Presidential Primary Election will be held for the Republican and Democratic Party nominations of President of the United States on Tuesday, February 28, 2012. **THE LAST DAY ON WHICH PERSONS MAY REGISTER IN ORDER TO BE ELIGIBLE TO VOTE AT THIS ELECTION TO BE HELD ON TUESDAY, FEBRUARY 28, 2012, IS MONDAY, JANUARY 30, 2012. PERSONS REGISTERING AFTER 5:00 P.M. ON MONDAY, JANUARY 30, 2012 ARE NOT ELIGIBLE TO VOTE AT THIS ELECTION.** Persons planning to register must determine when the office of the City or Township Clerk or the office of the County Clerk or the Secretary of State branch office will be open for registration in person. To register by mail, you may obtain an application form from www.michigan.gov/sos and mail it to your county or local clerk.

Persons entitled to be registered voters in said City/Township must possess the following qualifications on or before the day of the Presidential Primary Election: (1) a citizen of the United States; (2) not less than 18 years of age; (3) a resident of the State of Michigan and the local municipality for not less than 30 days prior to the Presidential Primary Election (MCL 168.492). In addition, qualified electors must be registered to vote not less than 30 days prior to the Presidential Primary Election (MCL 168.497).
